CASTING A VOTE: To vote for the candidate of your choice, darken the oval (●) at the LEFT of the candidate's name. If you make a mistake, return your ballot to the Election Official and obtain another. Do not attempt to change any marks made in error.
WRITE-IN: A write-in vote will NOT be counted unless the vote is for a DECLARED write-in candidate. To vote for a write-in candidate, darken the oval to the LEFT of the name you have written in or your vote will not be counted.

If you do not wish to vote a straight party ticket, do not make a mark in this section, and proceed to voting the ballot by office.</p> <p>(2) To vote a straight party ticket for the party of your choice for all candidates on this ballot, except for candidates described in (3) below, darken the oval to the left of the party name and do not make any other marks on this ballot.</p> <p>(3) To vote for any candidate for an at-large office to which more than one (1) person may be elected, you must darken the oval for each candidate you wish to vote for.
