ORDINANCE NO. 12-2018

AN ORDINANCE AMENDING ORDINANCE NO. 7-1983  
(THE CLARK COUNTY TRAFFIC CONTROL ORDINANCE),  
ARTICLE 9 (STOPPING, STANDING OR PARKING  
PROHIBITED IN SPECIFIED AREAS)

**WHEREAS**, the Board of Commissioners of Clark County, Indiana (the "Board"), is the executive body of Clark County government pursuant to the provisions of Ind. Code § 36-2-2-2; and,

**WHEREAS**, the Board is also the legislative body of Clark County government pursuant to the provisions of Ind. Code § 36-1-2-9; and

**WHEREAS**, the Board has previously passed and adopted Ordinance 7-1983 entitled "The Clark County Traffic Control Ordinance, which said Ordinance has been amended from time-to time; and,

**WHEREAS**, upon recommendation of the Clark County Engineer, the Board now finds it to be appropriate and necessary to again amend The Clark County Traffic Control Ordinance in order to specify additional areas where parking is prohibited in the County roads and streets in the unincorporated territory of Clark County that are more fully described in this Ordinance, and the Board adopts this Ordinance for such purposes.

**NOW, THEREFORE, IT IS HEREBY ORDAINED BY THE BOARD OF CLARK COUNTY COMMISSIONERS, AS FOLLOWS:**

1. That Article 9 of Ordinance NO. 7-1983 is hereby amended to add the following section and language:

**SECTION 9-10. PARKING PROHIBITED WITHIN OR ON MEDIANS.**

**NO PERSON SHALL PARK ANY TYPE OF VEHICLE WITHIN OR ON THE MEDIAN OF ANY COUNTY ROAD OR STREET.**

2. All other terms and provisions of Ordinance No. 7-1983, as previously amended, shall remain in full force and effect.
3. That this Ordinance shall be effective upon final passage and approval by the Board of Commissioners.
