**AN ORDINANCE DIVIDING CLARK COUNTY INTO COUNCIL DISTRICTS  
AND REVISING AND ESTABLISHING COUNCIL DISTRICT  
BOUNDARIES FOR ELECTION PURPOSES**

**WHEREAS**, the Board of Commissioners of Clark County, Indiana (the “Board”), is the executive body of Clark County government pursuant to the provisions of Ind. Code § 36-2-2-2; and,

**WHEREAS**, the Board is also the legislative body of Clark County government pursuant to the provisions of Ind. Code § 36-1-2-9; and

**WHEREAS**, pursuant to I.C. 36-2-3-4, the Board shall divide the County into four (4) single-member contiguous Council districts during the first year after a year in which a federal decennial census is conducted; and

**WHEREAS**, pursuant to I.C. 36-2-3-4, the four (4) Council districts must:

- (1) be compact, subject only to natural boundary lines (such as railroads, major highways, rivers, creeks, parks, and major industrial complexes);
- (2) not cross precinct boundary lines;
- (3) contain, as nearly as possible, equal population; and
- (4) include whole townships, except when a division is clearly necessary to accomplish redistricting under this section.

**NOW, THEREFORE, IT IS HEREBY ORDAINED BY THE CLARK COUNTY COMMISSIONERS, AS FOLLOWS:**

**1. Adoption of Maps and List of Precincts Delineating Council Districts:**

The Board hereby approves and adopts the Council district maps and the list of precincts delineating the Council districts attached hereto and incorporated herein as **Exhibit “A”** pursuant to I.C. 36-2-3-4 and I.C. 36-2-3-4.7.

**2. Filing of Ordinance with Clark County Clerk:**

A copy of this Ordinance shall be filed with the Clerk of Clark County Clerks after its final adoption.

3. **Effective Date:** This Ordinance shall be in full force and effect upon its passage and promulgation as evidenced by the affirmative signatures of the undersigned as the majority of the duly elected and serving members of the Board.


