ORDINANCE NO. 9 -- 2011

**AN ORDINANCE ESTABLISHING CERTAIN REAL PROPERTY ENDORSEMENT FEES TO BE ASSESSED AND COLLECTED BY THE CLARK COUNTY AUDITOR, AND REQUIRING THE DEPOSIT OF SUCH FEES BY THE AUDITOR INTO THE COUNTY'S DEDICATED PLAT BOOK MAINTENANCE FUND.**

WHEREAS, in accordance with the provisions of Indiana Code § 36-2-9-18(d), this Board of Commissioners of Clark County, Indiana (this "Board"), as the legislative body of such county, may adopt an ordinance authorizing the Clark County Auditor (the "Auditor") to collect a fee of up to Five Dollars (\$5.00) for each legal description of each lot, parcel, or tract contained within in each deed for which the Auditor makes a real property endorsement; and,

WHEREAS, this Board believes it is in the best interest of the County to establish such fees, and to have the Auditor collect such fees, in order to partially compensate for the administrative cost of services provided.

BE IT THEREFORE ORDAINED by this Board in accordance with the provisions of Indiana Code § 36-2-9-18(d) as follows:

1. The Auditor of Clark County, Indiana shall collect a fee of Five Dollars (\$5.00) for each legal description of each lot, parcel, or tract contained within in each deed for which the Auditor makes a real property endorsement.
2. The fees established by this Ordinance shall be in addition to any other fees provided by law.

3. The Auditor shall be deposited by the Auditor into the County's dedicated Plat Book Maintenance Fund, and such funds may be disbursed upon proper appropriation and/or claims approval for all legal purposes of such fund.

4. This Ordinance replaces and supercedes all prior ordinances establishing real property endorsement fees to be assessed and collected by the Auditor.

5. This Ordinance shall be in full force and effect upon its adoption by the Board.






