# ORDINANCE NO. PJ-1993

# AN ORDINANCE ESTABLISHING THE CLARK COUNTY SHERIFF'S DEPARTMENT EXPENSE AND SEIZURE FUND

WHEREAS, I.C. 36-1-3 empowers local units of government to exercise powers of self-government needed for their effective operation so long as the power so exercised is not reserved to the state;

WHEREAS, adoption of an ordinance is necessary for Clark County, Indiana government to exercise such local powers pursuant to I.C. 36-1-3-6;

WHEREAS, the Board of Commissioners of Clark County, Indiana is the county executive pursuant to I.C. 36-2-2-2;

WHEREAS, the Board of Commissioners of Clark County, Indiana is the legislative body for Clark County, Indiana pursuant to I.C. 36-1-2-9;

WHEREAS, from time to time the Clark County Police Department (aka Clark County Sheriff's Department) is awarded monies by grant or as a result of seizures of property pursuant to court order and direction;

WHEREAS, there appears to be no regularity or consistency concerning receipt of such funds so as to reasonably rely on such receipt, for business purposes, into regular anticipated income for the Clark County, Indiana General Fund;

WHEREAS, it is necessary to the public interest that the Clark County Police Department be able to utilize such funds, whenever made available, for law enforcement or other governmental purposes.

# NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF CLARK COUNTY, INDIANA AS FOLLOWS:

- 1. That each and every recital set forth hereinabove is adopted into this Ordinance;
- 2. That there is hereby established the Clark County Sheriff's Department Expense and Seizure Fund;
- 3. That said fund shall be non-reverting in nature and shall be funded by all monies received by the Clark County Police Department in the nature of law

enforcement grants or other payments made as a result of property seizures and forfeitures, etc. All expenditures therefrom shall be exclusively made and controlled by the Board of Commissioners of Clark County, Indiana;

- 4. That expenditures from said fund may be made for the following purposes:
  - a. "Buy money" in controlled substance or marijuana transactions when necessary to obtain reliable information of probable violations of the law;
  - b. Continuing education expenses for law enforcement personnel associated with the Clark County Police Department;
  - c. Equipment expenses for purchases of equipment necessary for the continued investigation of drug and alcohol expenses and efforts toward eradication of illegal drugs;
  - d. Petty cash expenditures in such monthly lump sums as are reasonable and as are approved by the Board of Commissioners, the County Sheriff and the Clark County Council;
  - e. Other expenses incurred by the Sheriff's Department operation, including overtime pay of Sheriff personnel, for the purpose of continued law enforcement services in Clark County, Indiana.
- 5. The Auditor of Clark County, Indiana is hereby directed to maintain and manage accurate accounting information concerning the receipts, expenditures and balances of this fund, to list it under the designation of "Special County Funds," along with already existing county funds not funded by direct property tax revenues on all financial reports and computer printouts made and generated for, and in the name of, the Board of Commissioners of Clark County, Indiana.
- 6. That no county warrants shall be authorized to issue for expenditures from this fund for payment of any monies except upon a verified itemized claim for same being submitted, reviewed and approved by the Board of Commissioners of Clark County, Indiana and without the commissioners' ordering the issuance of

such a warrant. No expenditures from this fund shall be made except in accord with this Ordinance. To the extent required by law, the Sheriff should utilize requests for appropriation from the Clark County Council for all expenditures from this fund before bringing such requests to the Board of Commissioners for approval.
