## ORDINANCE NO. \_\_\_\_\_\_\_--2016

## AN ORDINANCE DESIGNATING A SCHOOL ZONE AND REGULATING TRAFFIC ON OR AROUND SILVER CREEK PRIMARY SCHOOL

WHEREAS, this Board of Commissioners of Clark County, Indiana (this "Board"), is the executive body of Clark County government pursuant to the provisions of Ind. Code § 36-2-2-2; and,

WHEREAS, this Board is also the legislative body of Clark County government pursuant to the provisions of Ind. Code 36-1-2-9; and

WHEREAS, pursuant to IC 9-21-1-3, and I.C. 9-21-5 et. Seq., a county may establish traffic regulation on a street upon which a school is located if the street is under the jurisdiction of the county; and

WHEREAS, that Silver Creek Primary School is located on Commerce Park Drive in Clark County, Indiana and is under this Board's jurisdiction; and

WHEREAS, this Board, upon the recommendation from the County Highway Department, desires to establish a school zone for Commerce Park Drive beginning at the Intersection of Commerce Park Drive and County Road 403 through the end of the Commerce Park Drive roadway and to additionally establish stop intersections at the Commerce Pass and Commerce Park Drive intersection and the Commerce Pass and Greenleaf Road intersection; and

NOW, THEREFORE, BE IT ORDAINED by this Board of Clark County Commissioners as follows:

- 1. That Commerce Park Drive, beginning at County Road 403 and through to the end of that roadway be designated a "school zone" and the speed limit shall be twenty (20) miles per hour when children are present and during posted school hours.
  - 2. That a stop sign shall be placed at the following two intersections:
    - a. On Commerce Pass at the intersection of Commerce Pass and Commerce Park Drive and
    - b. On Commerce Pass at the intersection of Commerce Pass and Greenleaf Road.
- 3. The county engineer is hereby ordered to post the necessary signs in accordance with Indiana law and INDOT specifications notifying drivers of the school zone speed limit beginning and if applicable, its ending. The county engineer is further ordered to post the necessary stop signs in accordance with Indiana law and INDOT specifications..
- 4. The school zone designation, speed limit signs and stop signs shall become effective when the signs giving notice have been posted.
- 5. That all law enforcement agencies with jurisdiction over Commerce Park Drive and Greenleaf Road are hereby authorized to enforce any speed limit or stop sign violation in accordance with state and local law.
- 6. The Ordinance shall be in full force and effect upon its passage and promulgation as evidenced by the affirmative signatures of the undersigned as the majority of the duly elected and serving members of this Board.
