# CLARK COUNTY COUNCIL CLARK COUNTY, INDIANA

Regular Meeting of February 12th, 2024

The regular scheduled meeting of the Clark County Council was called to order at 6:00p.m. by Council President Barbara Hollis.

Those in attendance stood for the pledge of allegiance to the American Flag.

Also present were Council Attorney Maxwell McCrite, Auditor Danny Yost, and Chief Deputy Auditor Jessica Huffman.

Councilperson Hollis offered the January 8<sup>th</sup>, 2024 Regular Council minutes. Councilperson Doherty motioned to approve the meeting minutes of January 8<sup>th</sup>, 2024 as presented. Councilperson Abbott seconded. Motion approved 7-0.

Councilperson Hollis requested any amendments that need to be made to the agenda. There were multiple amendments. Tom Lowe is requesting multiple Salary Ordinances to be considered. Councilperson Vissing motioned to approve the agenda as amended. Councilperson Grooms seconded. Motion approved 7-0.

Councilperson Doherty motioned to acknowledge a receipt of the fund's report provided by the Auditor's office. Councilperson Miller seconded the motion. Motion approved 7-0.

Committee Reports: Councilperson Lenfert provided an update on the E911 building. The building was completed second quarter of 2023. Before moving into the new facility, a major water leak happened. After months of remediation, the new facility is up and operational.

Public Comments: Kaitlyn Blessit – Kaitlyn Blessit requested if the Council would consider recording the meetings for those who cannot be in attendance. Kaitlyn also had a few questions about Salary Ordinance's. "I'm shocked to see some of the salaries in the Sherrif Department. Scottie Maples salary went from \$170,000.00 to \$184,000.00. I'm from Louisville and Sheriff Aubrey is making around \$150,000.00. There are no term limits over there. Louisville is a much bigger County and has a higher crime-rate. I would like to understand how the salaries are determined. The salary seems excessive for a Sheriff in his first term. Morgan Maples also jumped up quite significantly. I don't think it's a great look for the Sheriff and his wife to jump so significantly. I think with everything going on in Clark County, we need to be careful with what our conflicts of interest look like."

Councilperson Lenfert – "I believe the salaries are based upon state statutes. The prosecutor salary is based upon the size of the county. The Sheriff's salaries are based on a percentage of the Prosecutor."

Councilperson Hollis – "We have had to increase positions within the Sheriff's department to attract workers to stay. We would pay for the training when we originally hire them in. Other units of local government would hire our officers away from us because we spent the money training them and they could offer them more money."

They provided a quote for an hourly rate and the scope of the work they would do. Their hourly rate is a not-to-exceed amount that is less than what we are currently paying consultants. Councilperson Grooms motioned to adjourn. Councilperson Miller seconded. Motion approved 7-0.

## AN ORDINANCE OF THE CLARK COUNTY COUNCIL CONCERNING ADDITIONAL APPROPRIATIONS FOR THOSE FUNDS WHICH DO NOT REQUIRE APPROVAL OF THE DEPARTMENT OF LOCAL GOVERNMENT FINANCE ORDINANCE NO. 4-2024

WHEREAS, certain extraordinary conditions have developed since the adoption of the existing annual budget so that it is necessary to appropriate more money than was appropriated in the annual budget.

Section I. BE IT ORDAINED by the Clark County Council of Clark County, Indiana that for expenses of Clark County government and its institutions for the year ending December 31, 2023, the following sums of money are herein specified subject to the law governing the same, such sum herein appropriated shall be held to include all expenditures provided by law.

Section II. THAT for the fiscal year there is hereby appropriated out of the various funds herein for the following specified amounts to meet such extraordinary emergencies which are declared to exist.
