May 22, 2025

The Board of County Commissioners of Clark County, Indiana met in Regular Session on May 22, 2025, at 5:00 p.m. in Room 103, Clark County Government Building, in Jeffersonville, Indiana.

Present at the meeting were Commissioners – Bryan Glover, Jack Coffman and Connie Sellers, Attorney Scott Lewis, Commissioners’ Assistant Sabrina Corbin and Auditor Danny Yost.

The Pledge of Allegiance was led by Commissioner Bryan Glover. Prayer was led by Commissioner Jack Coffman.

Approval of the Minutes

Commissioner Sellers motioned to approve the May 8, 2025 Regular Meeting Minutes. Commissioner Coffman seconded. Motion approved 3-0.

Danny Yost presented the claims and payroll for May 22, 2025. Commissioner Sellers motioned to approve the claims and payroll. Commissioner Coffman seconded. Motion approved 3-0.

Commissioner Glover asked for any amendments to the agenda if not he would entertain a motion to approve. Commissioner Coffman motioned to approve the agenda as presented. Commissioner Sellers seconded. Motion approved 3-0.

II. New Business:

A. Commissioner, Bryan Glover presented Rezoning Ordinance- Plan Commission 2025-08. This zoning change came before the Commissioners with a change of zone request from B1 to R2. This property is located on Mount Zion Road in Henryville and is .50 AC. This change is requested by Ridge Wilson. The purpose of the rezoning is to be able to build a single family home. The Plan Commission met on May 14, 2025 and gave a favorable

recommendation. Commissioner Glover opened a public hearing and no one was there to speak for or against. Commissioner Glover closed the public hearing. Commissioner Sellers motions to approve Ordinance 14-2025 which is An Ordinance Approving an Amendment to the Clark County Zoning Map on Recommendation by the Clark County Plan Commission. Commissioner Coffman seconded. Motion approved 3-0.

- B. Scott Lewis, County Attorney, presented the Paving Agreement for CR-403 and Perry Crossing. Brian Dixon, County Engineer, reviewed the bid from the last meeting and recommended MAC Construction & Excavating Inc. This bid was for the amount of \$541,265.00. Commissioner Sellers motion to approve the contract for MAC Construction & Excavating Inc in the amount of \$541,265.00 for paving and milling. Commissioner Coffman seconded. Motion approved 3-0.
- C. Bryan Glover, County Commissioner presented Appointment to Community Correction Board. According to Section 2 (a) (8) John Benningfield is recommended to fill the spot, Also under Section 2 (a) (10) a representative from the Juvenile Detention, Director of Juvenile Detention Jennifer Snawder is recommended. Under 12 (A) One member of the county fiscal body or member. Councilman, Chris Fox has shown interest in this spot. Under 12 (F) One mental health administrator. Beth Keeney has been serving in that spot but was never appointed, so we will now appoint her. Under 12 (G) Four lay people at least one whom is must be a member of minority race. Those people are as followed Ann Carruthers, Shilese Stover, and Phil Stucky. Commissioner Coffman motion to approve recommended people for Appointment to Community Correction Board. Commissioner Sellers seconded. Motion approved 3-0.


