#### **REGULAR MEETING**

### **CLARK COUNTY BOARD OF COMMISSIONERS**

#### January 8, 2009

The Board of County Commissioners of Clark County, Indiana met in Regular Session on January 8, 2009 at 4:00 p.m. in Room 404, Clark County Government Building, Jeffersonville, Indiana.

Present at the meeting were Commissioners – Ed Meyer, Mike Moore and Les Young, County Auditor, Keith Groth, County Attorney, Greg Fifer, Commissioner Secretary, Kristi James and Deputy Secretary from the Auditor's Office, Shirley Bell.

#### **Approval of Minutes**

Auditor Keith Groth presented the minutes from December 23, 2008 meeting for approval. Mike Moore made the motion to approve and Ed Meyer seconded. The motion was approved 2-0.

## Approval of Claims/Payroll

**Auditor Keith Groth** presented the payroll for approval stating all figures had been checked and verified. Mike Moore made the motion to approve and Les Young seconded. The motion was approved 3-0.

#### Resolution 1-2009

Les Young made the motion to dissolve Resolution 1-2009. The motion was seconded by Mike Moore and the motion was approved 3-0.

#### **Election of Officers for 2009**

Ed Meyer stated that election officers needed to be held. Les Young made the motion to nominate Ed Meyer for President and Mike Moore for Vice-President for 2009. Ed Meyer seconded the motion and the motion carried 3-0.

### Magistrate Space

Judge Vicki Carmichael, later joined by Judge Dan Moore, spoke about the need for space for a second Magistrate's courtroom. Ed said he will look about space on the Third Floor to move the Probation courtroom to free up the space for the courtroom to be together with the other courtrooms. Ed questioned if the courts could help with the costs. After discussion the Board requested more information on costs and space available. Ed will check out some of the space with the Building Authority.

## **Contract for Attorney Greg Fifer**

A motion was made by Mike Moore to accept the contract for Greg Fifer as County Attorney for the Board of Commissioners and seconded by Les Young. The motion was approved 3-0.

Tabled Amendment #4 - Subdivision Control Ordinance to next meeting.

#### **Auditor's Report**

Auditor Keith Groth wished the Board and Attorney Fifer a positive 2009 and looked forward to working with them.

## Attorney's Report/Comments

Attorney Greg Fifer had no business or comments at this time.

# 2009 Appointments -

Each appointment was addressed. The Highway Department was approved 3-0 with a motion made by Mike Moore and seconded by Les Young. The commissions or committees listed were approved 3-0 by a motion from Les Young and seconded by Mike Moore.:

ADA Compliance Officer which is Greg Fifer, Adult Entertainment Commission, Alcoholic Beverage Commission, Animal Disease Coordinator, Animal Shelter Advisory Committee, Board of Aviation, & Board of Zoning Appeals.

Borden Tri-County Regional Water District stayed the same. Under the Cemetery Commission David Abbott was reappointed with Mike Moore making the motion and Les Young making a second. The appointment was approved 3-0.

The Charlestown Fire Protection District appointed Ralph Webb to replace Dale Robinson with Mike Moore making the motion and seconded by Les Young. The motion carried 3-0.

Charlestown-Clark County Library Board appointed LaDonna Johnson with a motion by Ed Meyer and seconded by Mike Moore. The motion carried 3-0.

Clark-Floyd Convention & Tourism Bureau reappointed the present members with a motion by Mike Moore and second by Ed Meyer. The motion carried 3-0.

Community Correction Advisory Board – appointment of Travis Haire to replace Terry Smith. The motion was made by Ed Meyer and seconded by Les Young

Drainage Board – Mike Moore made the motion to appoint Bill Collins to replace Jared Sawin and Les Young seconded. The motion carried 3-0.

Emergency Management Advisory Council – Mike Moore made the motion to continue with stated appointments and Les Young seconded. The motion carried 3-0.

Health Department – Ed Meyer made the motion for Dr. Charles Kemper to stay on and Les Young seconded. The motion carried 3-0.

INAAP Reuse Authority – Ed Meyer made the motion for Mark Robinson to continue and Mike Moore seconded. The motion carried 3-0.

I.O.S.H.A., Jeff-Clark Building Authority Trustee, Jeffersonville Plan Commission, Jeffersonville Township Public Library, KIPDA, Monroe Township Fire Protection District, New Washington Fire Protection District, Physician Advisory Corporation and Plan Commission all as stated with a motion by Les Young and seconded by Mike Moore. The motion carried 3-0.

Property Tax Assessment Board of Appeals, Public Defender Board, Public Safety Authority Corp, Redevelopment Authority, Redevelopment Commission, Regional Water and Sewer District Board, River Hills Economic Development District, SIEDC, Solid Waste Management District (add Les Young in place of Ralph Guthrie), and Southern Seven Workforce – a motion was made by Mike Moore to accept all these appointments and seconded by Ed Meyer. The motion carried 3-0.

Mike Moore brought up the pay amount for Drainage Board members and if that could be removed. Attorney Fifer will check into whether that can be done and if there is an ordinance in effect.

#### Sheriff's Business

**Sheriff Rodden** stated that the contract with Griffin Industries has not been signed yet and Ed Meyer asked Sheriff Sheriff Rodden to check with Griffin Industries before signing this contract. A motion was made by Mike Moore and seconded by Les Young to give Ed Meyer authority to sign this contract outside of the meeting. The motion was approved 3-0.

## **Highway Dept**

Engineer Hyun Lee presented a letter from Butler, Fairman & Seufert concerning Bridge 63 at Elrod Road in Union Township at \$380,000. (letter in minutes)

Mr Lee presented the Contract Bids for 2009 and letters will be sent to those chosen to provide the items that he recommended. The bid sheet is included in the minutes. Mike Moore made a motion to accept the bid sheet and Les Young seconded. The motion was approved 3-0. Mike Moore asked if we could consider Bid Bridge for future bids and talk to them. This company operates online for pricing many of the items on the county bid sheets.

# **RQAW Consulting Engineers & Architects**

**Melvin Beeker** appeared before the Board and offered his services from his company. He presented the members with a handout from his company.

#### **Public Comments**

Mike Moore and Les Young would like to see the Public Comments section moved up to the top of the Agenda after approving minutes and claims/payroll and made item C. Mike Moore made the motion and Les Young seconded. The motion was approved 3-0.

Les Young stated since he was new he would like to see what bills are being paid and wanted to make a motion that they are given them. Mike Moore seconded the motion and it was approved 3-0.

Mike Moore asked if Handicap Parking could be designated outside on Watt Street at the steps. Sheriff Rodden will check into this.

A motion to adjourn was made by Mike Moore and seconded by Les Young. The meeting was adjourned.
