ORDINANCE NO. 38 -2021

AN ORDINANCE DIVIDING CLARK COUNTY INTO COMMISSIONER DISTRICTS AND REVISING AND ESTABLISHING COMMISSIONER DISTRICT BOUNDARIES FOR ELECTION PURPOSES

WHEREAS, the Board of Commissioners of Clark County, Indiana (the "Board"), is the executive body of Clark County government pursuant to the provisions of Ind. Code § 36-2-2-2; and,

WHEREAS, the Board is also the legislative body of Clark County government pursuant to the provisions of Ind. Code § 36-1-2-9; and

WHEREAS, pursuant to I.C. 36-2-2-4, the Board shall divide the County into three (3) Commissioner districts during the first year after a year in which a federal decennial census is conducted; and

WHEREAS, pursuant to I.C. 36-2-2-4, the three (3) Commissioner districts must be composed of contiguous territory and must be reasonably compact. The district boundaries drawn by the Board must not cross precinct boundary lines and must divide townships only when a division is clearly necessary to accomplish redistricting ~.

NOW, THEREFORE, IT IS HEREBY ORDAINED BY THE CLARK COUNTY COMMISSIONERS, AS FOLLOWS:

1. Adoption of Maps and List of Precincts Delineating Commissioner Districts:

The Board hereby approves and adopts the Commissioner district maps and the list of precincts delineating the Commissioner districts attached hereto and incorporated herein as **Exhibit "A"** pursuant to I.C. 36-2-2-4 and I.C. 36-2-2-4.7.

2. Filing of Ordinance with Clark County Clerk:

A copy of this Ordinance shall be filed with the Clerk of Clark County Clerks after its final adoption.

3. Effective Date: This Ordinance shall be in full force and effect upon its passage and promulgation as evidenced by the affirmative signatures of the undersigned as the majority of the duly elected and serving members of the Board.






