

**RESOLUTION NO. 11-2008**

**A RESOLUTION CONFIRMING  
ADDITIONS TO COUNTY ROAD INVENTORY**

**WHEREAS**, the Board of Commissioners of Clark County ("Board") is the County Executive under I. C. 36-2-2-2 and also functions as the County legislative body under I. C. 36-1-2-9(1);

**WHEREAS**, a statutory component of the Board's responsibilities includes exclusive responsibility for operation and maintenance of the Clark County, Indiana highway and road system;

**WHEREAS**, it becomes necessary, from time-to-time, for the Board to take official action to add additional road miles to the County's road inventory for service and maintenance purposes, as well as for computation of state distributions to assist the County Highway Department in such function;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF CLARK COUNTY, INDIANA THAT:

1. That each and every recital set forth hereinabove is adopted into this Resolution;
2. That the Board, by official action, hereby confirms the addition of the following roadways located in Clark County, Indiana, into the Clark County highway system to be hereafter included in all listings of county-maintained roads:
