Regular Meeting of March 19, 2010

The regular scheduled meeting of the Clark County Council was called to order at 5:00 p.m. by Council President Jack Coffman.

Those in attendance stood for the pledge of allegiance to the American Flag.

Roll call showed members present and absent as follows:

Also present were Council Attorney Scott Lewis, County Auditor Keith Groth, Chief Deputy Auditor Vicki Hinkle and Benefits Coordinator Tracy Boettcher.

President Coffman requested proof of Notice to Taxpayers of the additional appropriations listed on the agenda. Scott Lewis, Attorney for the Council stated for the record that publication of Notice of Taxpayers ran in the Evening News ten (10) days prior to this meeting as required by I.C.6-1.11-18-5 and advised the council to proceed.

Councilperson Hollis made a motion to approve the minutes for the February 8 and February 23 meeting. Councilman Smith seconded the motion. Carried 7-0.

At this time Councilperson Hollis made a motion to amend the agenda to consider tabled items after the Board of Aviation. Councilman Smith seconded the motion. Carried 7-0. Councilman Abbott then made a motion add the county assessor to the agenda after the Board of Aviation with a second from Councilman Moore. Carried 7-0.

First on the agenda was the Board of Aviation with a request for a transfer of funds. Councilperson Hollis made a motion to approve the request with a second from Councilman Smith. Carried 7-0.

Vicky Haire, County Assessor came before the council to inform them of the changes the state has made for assessing and that it will require additional appropriations to be able to get the reassessment completed.

The council next acted on tabled items from previous meetings as follows:

Superior Court #2 Councilman Moore made a motion to approve the salary ordinance for the court reporters with a second from councilman Vissing. Carried 7-0. Councilperson Hollis then made a motion to table the remaining request from the court until the next meeting so they could look into the mandate from the court. Councilman Abbott seconded the request. Carried 7-0. Councilman Abbott then made a motion to have an executive session on April 12 at 4:00 before the regular council meeting to discuss the mandate from Superior Court #2. Councilman Moore seconded the motion. Carried 7-0.

<u>Building Authority</u> Councilperson Hollis made a motion to deny the request for additional appropriation from the Rainy Day Fund. Councilman Moore seconded the motion. Councilperson Hollis then made a motion to approve the request of \$534,500.00 from the CEDIT Fund. Councilman Smith second the motion. Carried 7-0.

<u>Treasurer</u> Councilman Abbott made a motion to approve the request from the Treasurer out of the Rainy Day Fund and to deny the request from the General Fund, the Riverboat Fund and the CEDIT Fund. Councilman Moore seconded the motion. Carried 7-0.

<u>Weights and Measures</u> Councilman Abbott made a motion to approve 2500.00 from the Rainy Day Fund and deny the 2500.00 from the Riverboat Fund. Councilman Moore seconded the motion. Carried 7-0.

<u>County Clerk and Voter Registration</u> Councilperson Hollis made a motion to deny the request made from the General Fund for the Clerk's office and the Voter Registration Office. Councilman Moore seconded the motion. Carried 7-0.

Next on the agenda was County Treasurer Janet Hurst with a request for additional appropriations from the General Fund, Rainy Day Fund, Riverboat Fund and a Salary Ordinance. Councilperson Hollis made a motion to deny all request with a second from Councilman Abbott. Carried 6-0. (Councilman Moore was out of the room at the time of the vote.)

County Clerk, Barbara Haas was next with several requests for additional appropriations and a salary ordinance. Councilman Moore made a motion to allow \$55,632.50 from the Rainy Day Fund and the salary ordinance and to deny the other requests. Councilman Abbott seconded the motion. Carried 7-0.

County Extension was next on the agenda with requests from the General Fund, Rainy Day Fund, Riverboat Fund and the CEDIT Fund. Councilman Vissing made a motion to allow the request from the Riverboat Fund and deny the rest. Councilman Abbott seconded the motion. Carried 6-1 with Councilman Coffman voting against the motion.

Next on the agenda was Soil and Water with additional appropriation requests. Councilman Abbott made a motion to approve the request from Rainy Day subject to Riverboat repaying Rainy Day in August when the Riverboat money comes in from the state. Councilman Vissing seconded the motion. The motion did not carry due to lack of a majority vote. Councilpersons Dickman, Hollis and Coffman voted against the motion. Councilperson Hollis then made a motion to deny the request from the General Fund, Rainy Day Fund and the CEDIT Fund and to table the request from the Riverboat Fund until the August meeting. Councilman Vissing seconded the motion. Carried 7-0.

Sheriff Danny Rodden was next to appear before the council with several additional appropriation request and also a request to appropriate the cash for citations. Councilman Abbott made a motion to table the additional appropriation request until the August meeting but to approve the citations. Councilman Moore seconded the motion. Carried 7-0. Councilman Moore then made a motion to allow the sheriff to use the Adult Usage Fund pursuant to the existing Ordinance. Councilperson Hollis seconded the motion. Carried 7-0.

Keith Groth, County Auditor was next with a request for an additional appropriation to pay for tax bills to be printed. Councilman Smith made a motion to deny the request from the General Fund, the Rainy Day fund and the CEDIT Fund and to table the request from the Riverboat fund until the August meeting. Councilman Vissing seconded the motion. Carried 7-0.

Next on the agenda was the Council budget with a request for additional appropriations. Councilperson Hollis made a motion to table the request from the Riverboat fund until the August meeting and deny the rest. Councilman Moore seconded the motion. Carried 7-0.

There were salary ordinances from all the courts next on the agenda. Councilperson Hollis made a motion to allow all the requests with a second from Councilman Smith. Carried 7-0.

New Business: Councilperson Hollis made a motion to have the taxes and benefits for the personnel that was moved to Rainy Day be paid out of the General Fund, Commissioners Budget. Councilman Moore seconded the motion. Carried 7-0. Councilperson Hollis then made a motion to reduce the General Fund Budget to match the state Budget Order and pay the difference from the Rainy Day Fund. Councilman Moore seconded the motion. Carried 7-0. Councilperson Hollis then made a motion to request the Commissioners to fund the encumbrances except for the jail from the Cum Cap Fund with a second from Councilman Moore. Carried 7-0.

Councilman Smith at this time made a motion to reappoint Stan Smith and Charlie Reisert to the Redevelopment Board. Councilman Moore seconded the motion. Carried 7-0.

There being no further business, the meeting was adjourned.
