Regular Meeting of October 11, 2010

The regular scheduled meeting of the Clark County Council was called to order at 7:00 p.m. by Council President Jack Coffman.

Those in attendance stood for the pledge of allegiance to the American Flag.

Also present were Council Attorney Scott Lewis, County Auditor Keith Groth, Chief Deputy Auditor Vicki Hinkle and Benefits Coordinator Tracy Boettcher.

President Coffman requested proof of Notice to Taxpayers of the additional appropriations listed on the agenda. Scott Lewis, Attorney for the Council stated for the record that publication of Notice of Taxpayers ran in the Evening News ten (10) days prior to this meeting as required by I.C.6-1.11-18-5 and advised the council to proceed.

Councilman Abbott made a motion to approve the minutes for the September 13 and September 20, 2010 meetings. Councilman Moore seconded the motion. Carried 7-

Amendments to Agenda: Councilperson Hollis made a motion to add Dan Eggerman to the agenda with an update on the Levy Appeal. She asked that he be added right after the Town of Covered Bridge. Councilman Moore seconded the motion. Carried 7-0.

Councilman Abbott made a motion to approve the agenda as amended with a second from Councilman Moore. Carried 7-0.

Public Comments: <u>Paul Fetter with Clark Co. Auto Auction</u> came before the council with a request for the council to pass a resolution concerning No Toll on the Bridges. Councilman Abbott made a motion to pass Resolution 2-2010. Councilman Moore seconded the motion. Carried 7-0.

<u>Kelly Khuri-</u> Questioned the Council on who would be responsible for paying back a loan for the Bond issue for the River Ridge Bond. She was told it would not be the responsibility of the County.

Next on the agenda was Larry Gupton with the Town of Covered Bridge. Councilman Moore made a motion to approve the Inter Local Agreement between the Town of Covered Bridge and the County with the changes contingent upon the approval of the Commissioners. Councilman Vissing seconded the motion. Carried 7-0.

At this time Dan Eggerman from Governmental Consulting Services to bring the Council up to date on the Levy Appeal. After listening to the information from Mr. Eggerman Councilperson Hollis made a motion to approve Resolution 3-2010 Petition for Levy Appeal. Councilperson Dickman seconded the motion. Carried 5-2 with Councilman Moore and Councilman Abbott voting against.

Next on the agenda was Recorder Mr. Dick Jones with a request for to appropriate cash in the ID Security Fund. Councilman Abbott made a motion to approve the request with a second from Councilman Moore. Carried 7-0.

The County Commissioners were next with a request for additional appropriations and also to appropriate cash in the Cum Cap Fund. Councilperson Hollis made a motion to deny the request for 7500.00 out of the General Fund and to table the request of 7500.00 from both the Rainy Day Fund and the Riverboat Fund until the meeting on the October 25, 2010 meeting. Councilman Moore seconded the motion. Carried 5-2 with Councilman Abbott and Councilman Vissing voting against the motion. Councilperson Hollis then made a motion to approve to appropriate the cash in the Cum Cap Fund with a second from Councilman Vissing. Carried 6-1 with Councilman Abbott voting against.

Judge Jerry Jacobi was next with a request to appropriate the cash in the PUF Fund and the Drug Court Fund. Councilman Abbott made a motion to approve the request with a second from Councilman Moore. Carried 7-0.

Next on the agenda was a request for a transfer of funds for the Emergency Management Fund. Councilman Smith made a motion to approve the request with a second from Councilperson Hollis. Carried 7-0.

Councilperson Hollis then made a motion to approve the transfer request for Veteran's Services. Councilman Smith seconded the motion. Carried 7-0.

The Council next acted on items tabled from the previous meeting. The first item was a request from the CEDIT Fund for \$165,000.00 for contract services from the Building Authority. Councilperson Hollis made a motion to approve \$100,000.00 and to table \$65,000.00 with a second from Councilman Smith. Carried 7-0. The next tabled item was 67,767.00 from the Riverboat Fund. Councilman Smith made a motion to deny due to the fact it was approved from Cum Cap. Councilman Vissing seconded the motion. Carried 7-0. Judge Carmichael was next with tabled items from Riverboat and LOIT with a request of 35,000.00 out of contract services. Councilman Moore made a motion to deny the request out of the Riverboat fund and approve it out of the LOIT Fund. Councilman Smith seconded the motion. Carried 7-0.
