The following appeared on the Plan Commission Agenda:

- 1. Call to Order: Connie Sellers called the meeting to order at 5:00 P.M.
- 2. Approval of the minutes from the Oct. 11, 2023 and the Nov. 8, 2023 meetings. Motion to approve was made by Wally; Bart seconded the motion. Motion carried 8-0.
- 3. Approval of the agenda items. Bart made a motion to approve the Agenda items, Guy seconded the motion. Motion carried 8-0.
- 4. David Nachand read the rules of the meeting.
- 5. Docket 2023-23-PC: J & J Development, 2709 Blackiston Mill Road, Clarksville, In. 47129, requests a zone change from AG to R-1 for 7.19 acres on Hwy 60, Parcel No. 10-09-10-900-164.000-030; and 10-09-10-900-163.000-030 to develop single family residences. This will be an addition to the Waters of Millan subdivision. The petition was previously tabled in October due to not having approval for wastewater. They have since received approval for Sellersburg wastewater. The petition was tabled again in November due to questions regarding an easement. Eric made a motion to approve the re-zoning, David Ruckman seconded the motion. Motion carried 5-2-1, with Guy abstaining.
