December 9th 2021

The Board of County Commissioners of Clark County, Indiana met in Regular Session on December 9<sup>th</sup>, 2021, at 5 p.m. in Room 418, Clark County Government Building, in Jeffersonville, Indiana.

### **Approval of the Minutes**

Commissioner Sellers made a motion to approve the November 24<sup>th</sup>, 2021, Regular Meeting Minutes. Commissioner Glover seconded. Motion approved 3-0.

Auditor Danny Yost presented the claims and payroll for December 15<sup>th</sup>, 2021. Commissioner Glover motioned to approve the claims and payroll. Commissioner Sellers seconded. Motion approved 3-0.
