CLARK COUNTY BOARD OF COMMISSIONERS

February 17th 2022

The Board of County Commissioners of Clark County, Indiana met in Regular Session on February 17th, 2022, at 5 p.m. in Room 418, Clark County Government Building, in Jeffersonville, Indiana.

Present at the meeting were Commissioners – Bryan Glover, Connie Sellers, and Jack Coffman, County Attorney Scott Lewis, Commissioners Assistant Pamela Armstrong, Clark County Engineer Brian Dixon, Assessor Butch Love, and Auditor Danny Yost.,

Pledge of Allegiance was led by Butch Love and the prayer was led by Jack Coffman.

Approval of the Minutes

Commissioner Sellers made a motion to table the February 9th, 2022 minutes. Commissioner Coffman seconded. Motion approved 3-0.

Commissioner Sellers made a motion to approve the December 22nd, 2022; January 6th, 2022; and January 20th, 2022 Regular Meeting Minutes. Commissioner Coffman seconded. Motion approved 3-0.

Auditor Danny Yost presented the claims and payroll for February 23rd, 2022. Commissioner Sellers motioned to approve the claims and payroll. Commissioner Coffman seconded. Motion approved 3-0.
