

ORDINANCE NO. 14-2006

**AN ORDINANCE ESTABLISHING THE CLARK COUNTY  
SUPPLEMENTAL REDEVELOPMENT AND PLANNING FUND**

**WHEREAS**, the Board of Commissioners of Clark County ("Board") is the legislative body of the County pursuant to I.C. 36-1-2-9. The Board also is the County Executive pursuant to I.C. 36-2-2-2 pursuant to section 2;

**WHEREAS**, a need exists to support the Clark County Redevelopment Commission ("Commission") and to provide a means by which external funds and funds appropriated by the County Fiscal Body can be deposited, managed and utilized to promote and support the legal functions of the Commission and its current and future staff;

**WHEREAS**, additionally, the Board is committed to finalize the pre-existing adult jail project in early 2007 and to dedicate time and efforts to try to contract with, or engage professional County Planner services. The Board believes that it is possible to obtain services of such a Planner who can also perform services as Executive Director of the Commission who will perform Planning and Redevelopment services under supervision of the Commission and under the related supervision and direction of the Board;

**WHEREAS**, a necessity exists for a fund to hold and retain donations and/or appropriated monies in order to support the Redevelopment and Planning functions addressed herein as the Commission becomes operative hereafter and must face expenses for professional and other services;

**NOW THEREFORE BE IT ORDAINED BY THE BOARD AS FOLLOWS:**

1. There is hereby established the "Clark County Supplemental Redevelopment and Planning Fund" to be held and managed by the Auditor of Clark County, subject to this Ordinance;


2. Said Fund shall be non-reverting in nature. Payments from said Fund shall issue only upon approval of a claim by this Board or by the approval of the Commission, without the necessity of further appropriation;

3. Monies permitted to be deposited in this Fund may include external donations or reimbursements to funds already under management of this Board, donations, state or other grants and any monies appropriated for economic development, Redevelopment or Planning purposes by the Clark County Council;

4. Expenditures from this Fund may be permitted to pay an Executive Director/Planner type of professional, support staff, supplies, legal, professional or other expenses of operations of the Commission. All service or hiring functions of the Commission for these purposes shall be a shared decision by the Commission and this Board.

5. The stated purpose of this enactment is to attempt to provide for long-range county Planning and Redevelopment services, to support the Commission in its work and to engage in mutually advantageous relationships with other federal, state or local agencies with Planning, Redevelopment or economic development purposes and goals.
