#### EXHIBIT "A"

Being 2.44 acres of land lying in Section 7, Township 1 South, Range 6 East, Wood Township, Clark County, Indiana. Same being part of those same lands as conveyed to the Wright Brothers Implements, LLC as described in Deed Record I-201112049. Same being bounded as follows:

Commencing at the Northwest corner of said Section 7; Thence along the Section Line and the North line of Wright, North 89°34′49″ East a distance of 617.10 feet to a fence corner; Thence leaving said Section Line, along the East line of Wright and the centerline of the ditch, South 26°55′24″ West a distance of 551.19 feet to a point, being the true place of beginning; Thence continuing along said ditch, South 26°55′24″ West a distance of 451.29 feet to a steel pin and cap set on the North right of way of State Road 60; Thence along said right of way, North 65°40′20″ West a distance of 177.11 feet to a mag nail; Thence leaving said right of way, along the West line of Wright and the Range Line, North 00°07′40″ West a distance of 362.34 feet to a set steel pin and cap; Thence South 84°52′00″ East, passing a steel pin and cap at 348.01 feet, for a total distance of 368.01 feet to the place of beginning.

Subject to any and all easements of record. Also subject to with the right to use a 30-foot Ingress, Egress and Utility Easement along the West line herein.
