CLARK COUNTY COUNCIL CLARK COUNTY, INDIANA Regular Meeting of August 9, 2010

The regular scheduled meeting of the Clark County Council was called to order at 5:00 p.m. by Council President David Abbott.

Those in attendance stood for the pledge of allegiance to the American Flag.

Also present were Council Attorney Scott Lewis, County Auditor Keith Groth, Chief Deputy Auditor Vicki Hinkle and Benefits Coordinator Tracy Boettcher.

President Coffman requested proof of Notice to Taxpayers of the additional appropriations listed on the agenda. Scott Lewis, Attorney for the Council stated for the record that publication of Notice of Taxpayers ran in the Evening News ten (10) days prior to this meeting as required by I.C.6-1.11-18-5 and advised the council to proceed.

Councilman Smith made a motion to approve the minutes for the July 12th meeting. Councilman Moore seconded the motion. Carried 7-0.

Amendments to Agenda: Clarksville TIF Reimbursement discussion. President Jack Coffman also wanted to move Prosecutor Steve Stewart to the first item on the agenda. Councilman Abbott made a motion to approve the amendments to the agenda with a second from Councilman Smith. Carried 7-0.

Councilmember Hollis made a motion to acknowledge the receipt of the Funds Report from the Auditor's office. Councilmember Moore seconded the motion. Carried 7-0.

Public Comments: <u>Barbara Haas</u> – made the council aware she will be on the September agenda to request her 22% reduction be reinstated for the fall election. She also made the Council aware that as of July 1, 2011 the State will no longer pay for the maintenance of the state wide voter registration system. She also informed the council the current voting machines will not be allowed for use in 2011.

<u>Randy Burton</u> with the 4H Board. Mr. Burton came before the council at the request of the commissioners to request \$7,500.00 from the Riverboat Fund to fund the remainder of what the commissioners obligated.

<u>Culpepper Cooper</u> came before the Council to update the council on all county insurance other then the Health Insurance.

At this time the Council opened the Public Hearing for the discussion and approval of the Bond Ordinance and the Appropriation Ordinance. Councilmember Hollis made a motion to approve Bond Ordinance 16-2010 and Appropriation Ordinance 17-2010. Councilman Vissing seconded the motion. A roll call vote went as followed:

First to go before the Council was Prosecutor Steve Stewart with requests to appropriate the cash in some of his grant funds to also a salary ordinance. Councilman Moore made a motion to approve all requests from the Prosecutor. Councilman Abbott seconded the motion. Carried 7-0.

Next on the agenda was the Commissioners with the inter local agreement with the Town of Borden for the Star Hill Road Project. Councilman Moore made a motion to table the inter local agreement until the September 13, 2010 meeting. Councilmember Hollis seconded the motion. Carried 7-0.

Superior Court #2 Drug Court was next on the agenda. Councilman Moore made a motion to allow the request with a second from Councilman Vissing. Carried 7-0.

The next request was from the Auditor's office from the Riverboat Fund to pay Umbaugh & Assoc. for the TIF work they did for the county. Councilman Moore made a motion to approve the request from the Riverboat Fund and deny it from the CEDIT Fund. Councilman Smith seconded the motion. Carried 7-0.

At this time Mark VanGilder with the Building Authority was next to go before the council to update on expenditures from the CEDIT funds for the Building Authority.

The next request came from Soil and Water with request for additional appropriations from the General Fund, Rainy Day Fund, Riverboat Fund and the CEDIT Fund. Councilman Abbot made a motion to approve the 11,470.00 for personal services and approve half of the other requests made from the Riverboat fund and deny all requests from the other funds. Councilman Moore seconded the motion. A roll call vote went as follows:

Motion failed.

Councilman Moore then made a motion to approve the 11,470.00 from the Riverboat fund and to deny all other requests from all funds. Councilperson Hollis seconded the motion. Carried 7-0.

Next on the agenda was Superior Court 1 Judge Carmichael with a request from General Fund, Rainy Day Fund, Riverboat Fund, CEDIT Fund and LOIT Public Safety fund to Pay for CHINS Cases. Councilperson Hollis made a motion to approve the requested 25,000.00 from the Riverboat Fund that was tabled from previous meetings with a second from Councilman Moore. Carried 7-0. Councilperson Hollis then made a motion to approve \$5000.00 from the Riverboat Fund and table 35,000. Table 35,000.00 from the LOIT Public Safety Fund and deny 5,000.00 until September and deny all requests from the other funds. Councilman Moore seconded the motion. Carried 7-0.

The tabled items for the Sheriff out of Co. General portion of LOIT was next on the agenda. Councilman Moore made a motion to table this request and to deny the tabled requests from Riverboat, Rainy Day and CEDIT Funds. Councilperson Hollis seconded the motion. Carried 7-0.

At this time the council acted on the tabled items from previous meetings.

<u>Auditor</u> Councilman Moore made a motion to approve \$5, 140.00 out of Riverboat fund and to deny \$2,069.00 to pay for the auditor's portion of the tax bills. Councilman Abbott seconded the motion. Carried 7-0.

<u>County Council :</u> Councilman Hollis made a motion to approve the request from the Riverboat Fund with a second from Councilman Moore. Carried 7-0.

<u>Old Business:</u> Councilman Abbott made a motion to set the budget dates as follows: Meet with Office holders September 1 & 2 from 9-4. September 20 Nonbinding reviews at 4:00 and Public Hearing for Budgets at 5:00. The budget adoption date is October 25 at 5:00 p.m. Councilman Moore seconded the motion. Carried 7-0.

<u>News Business:</u> The council will need to send a letter to office holders concerning balances in appropriations. No claims will be paid if money and cash are not in the fund or appropriation to support the claim.

<u>Auditor Comments:</u> The Auditor let the council know the Tax Sale has been scheduled for October 4, 2010 at 10:00 a.m.

There being no further business, the meeting was adjourned.
