Regular Meeting of October 4th 2021

The regular scheduled meeting of the Clark County Council was called to order at 6:00 p.m. by Councilperson Barbara Hollis.

Absent

Those in attendance stood for the pledge of allegiance to the American Flag.

Roll call showed members present and absent as follows:

Also present were County Auditor Danny Yost and Chief Deputy Auditor Jessica Huffman.

President Hollis requested proof of the Notice of Taxpayers of the additional appropriations listed on the agenda. Auditor Danny Yost stated for the record that publication of the Notice of Taxpayers ran in the Evening News ten (10) days prior to this meeting as required by I.C.6-1.11-18-5 and advised the council to proceed.

Councilperson Hollis offered September 13, 2021 Regular Council minutes. Councilperson Newland motioned to table the Regular meeting minutes of September 13, 2021. Councilperson Miller seconded. Motion carried 7-0.

Councilperson Hollis requested any amendments that need to be made to the agenda. The Commissioners added a salary ordinance as well as a transfer of appropriations, the Highway Department added a transfer of appropriations, and the Treasurer added a motion request. Councilperson Doherty motioned to approve the agenda as amended. Councilperson Miller seconded. Motion carried 7-0.

Councilperson Doherty motioned to acknowledge the receipt of the fund's report provided by the Auditor's office. Councilperson Vissing seconded the motion. Motion carried 7-0.

Councilperson Hollis presented the ordinances for the 2022 Budget. Councilperson Hollis requested any public comments. There were no public comments. AN ORDINANCE OF THE CLARK COUNTY COUNCIL CONCERNING ADDITIONAL APPROPRIATIONS FOR THOSE FUNDS WHICH DO NOT REQUIRE APPROVAL OF THE DEPARTMENT OF LOCAL GOVERNMENT FINANCE ORDINANCE NO. 19-2021

WHEREAS, certain extraordinary conditions have developed since the adoption of the existing annual budget so that it is necessary to appropriate more money than was appropriated in the annual budget.

Section I. BE IT ORDAINED by the Clark County Council of Clark County, Indiana that for expenses of Clark County government and its institutions for the year ending December 31, 2018, the following sums of money are herein specified subject to the law governing the same, such sum herein appropriated shall be held to include all expenditures provided by law.
