July 13, 2017

The Board of County Commissioners of Clark County, Indiana met in Regular Session on July 13, 2017, at 5 p.m. in Room 404, Clark County Government Building, Jeffersonville, Indiana.

Approval of the Minutes

Commissioner Glover had a question about the June 29, 2017, minutes. Commissioner Glover made a motion to approve June 29, 2017, Regular Meeting Minutes with the correction adding the names to Item D. Commissioner Coffman seconded. Motion approved 2-0 with Commissioner Sellers absent.

Commissioner Glover motioned to approve the agenda as presented. Commissioner Coffman seconded. Motion approved 2-0.
