ORDINANCE NO 6 - 2007 Ordinance Establishing Cumulative Bridge Fund

BE IT RESOLVED, by the Board of Commissioners of Clark County, Indiana, that it is desired and deemed necessary to re-establish the Cumulative Bridge Fund for the following purposes:

To provide funds for the costs of construction, maintenance and repair of bridges, approaches and grade separations, and for making county wide bridge inspections and safety ratings of all bridges in Clark County not on the State Highway System.

BE IT FURTHER RESOLVED, that this board will adhere to the provisions of 1.C. 8-16-3. The proposed fund will not exceed <u>two</u> cents (\$. <u>02</u>) on each one hundred dollars (\$100.00) of assessed valuation beginning with taxes levied and payable in 2008.

BE IT FURTHER RESOLVED, that proofs of publication of the public hearing held on the 5th day of April, 2007 and a certified copy of this ordinance be submitted to the Department of Local Government Finance of the State of Indiana as provided by law. Said Cumulative Bridge Fund is subject to the approval of the Department of Local Government Finance.
